

Calyx® PointCentral™ Software License Agreement  
(v.7.2)

READ THIS LICENSE AGREEMENT (“AGREEMENT”) CAREFULLY BEFORE INSTALLING THIS SOFTWARE. THIS AGREEMENT, BETWEEN CALYX TECHNOLOGY, INC., DBA CALYX SOFTWARE (“CALYX”) AND YOU (“YOU” OR “LICENSEE”) STATES THE TERMS AND USE OF POINTCENTRAL (PREVIOUSLY SOLD SEPARATELY AS POINT® AND POINT DATA SERVER™/ PDS™) AND ALL ACCOMPANYING DOCUMENTATION (“SOFTWARE”). THE TERM “DOCUMENTATION” INCLUDES ALL USER MANUALS AND OTHER MATERIALS RELATED TO THE SOFTWARE. THE TERM “SOFTWARE” ALSO INCLUDES ANY UPDATES, BUG FIXES, ENHANCEMENTS, AND OTHER MODIFICATIONS TO THE SOFTWARE. THIS AGREEMENT CONTAINS BINDING OBLIGATIONS AND RESTRICTIONS ON LICENSEE’S USE OF THE SOFTWARE, DISCLAIMERS, LIMITATIONS ON CALYX’S LIABILITY, INDEMNIFICATION OBLIGATIONS, AND OTHER IMPORTANT TERMS.

CALYX LICENSES THE SOFTWARE TO LICENSEE ONLY UPON THE CONDITION THAT LICENSEE ACCEPTS ALL OF THE TERMS CONTAINED IN THIS AGREEMENT. BY CLICKING THE “I ACCEPT THE TERMS IN THE LICENSE AGREEMENT” BUTTON PRIOR TO INSTALLATION, LICENSEE AGREES THAT LICENSEE UNDERSTANDS THIS AGREEMENT AND ACCEPTS ITS TERMS. BY INSTALLING THE SOFTWARE, YOU ARE BINDING YOURSELF AND THE BUSINESS ENTITY THAT YOU REPRESENT TO THE TERMS OF THIS AGREEMENT.

**DEFINITIONS.**

“Client Software” refers to the Point software portion of the Software.

“Server Software” is the PointCentral server (previously known as Point Data Server or PDS) portion of the Software.

“Seat” is defined as the right to access or use the Software on a computer.

“Service Providers” refers to the companies providing services via the Interfaces.

“Software” refers to Client Software and Server Software collectively.

**1. GRANT OF LICENSE.**

1.1 Commercial License. Subject to Licensee’s compliance with the terms and conditions of this Agreement, Calyx grants Licensee a non-exclusive and non-transferable (except as permitted under Sections 5 and 6) license to access and use the Client Software, whether locally or remotely, on as many computers as the number of Seats Licensee has purchased, solely for Licensee’s internal business purposes; and a license to install and use the Server Software on a single server, solely for internal business purposes. Licensee’s license to use the Client Software is limited to, and Licensee shall not use the Client Software in excess of, the number of Seats for which Licensee has paid Calyx the required license fee. Licensee may make an unlimited number of connections to the Server Software from the Client Software so long as each Client Software connecting to the Server Software is an employee or contractor of Licensee and the appropriate number of Seats have been acquired. Licensee must purchase additional licenses if Server Software is used on additional servers.

1.2 Use of Third Party Hosting Company. Licensee may contract with a hosting company to host the Software solely for Licensee’s remote access, provided that the number of access point does not exceed the number of Seats that Licensee has purchased.. Licensee is solely responsible for adhering to this Agreement. No license is granted to hosting company by way of this Agreement.

2. LICENSE RESTRICTIONS. Calyx reserves all rights in the Software not expressly granted to Licensee in this Agreement. Except as expressly specified in Sections 1, 5 and 6, Licensee may not: (a) copy, modify, translate, adapt, or prepare derivative works of the Software; (b) sell, license, sublicense, transfer, lease, lend, rent, publish, display, or otherwise distribute the Software to any third party; or (c) disassemble, decompile, or otherwise reverse engineer the Software, in whole or in part, or permit or authorize a third party to do so, except to the extent such activities are expressly permitted by law notwithstanding this prohibition.

3. LIMITED USE LICENSING RESTRICTIONS. In the event Licensee has been given a right to use Software for limited purpose (i.e., approved educational institutions, approved entities in connection with criminal or civil investigations, and Calyx’s Interface vendors), Licensee is prohibited from using the Software to originate mortgage loans. Further, the following Sections of this Agreement are not

applicable to limited use Software licensing: Use of Third Party Hosting Company, License Transfer, Assignment, Interfaces, Disclosure of Information, Availability of Interfaces, Software Refunds, and Inter-Company Cost Recovery.

4. **OWNERSHIP.** The Software is licensed, not sold. Calyx retains ownership and all rights, title, and interest in the Software and related materials, including all worldwide patent rights, copyrights, trademarks, trade secrets, know-how and any other intellectual property rights therein. Licensee must take reasonable steps to protect Licensor's intellectual property rights. Licensee may not delete or in any manner alter the copyright, trademark, and other proprietary rights notices or markings appearing on the Software as delivered to Licensee.
5. **LICENSE TRANSFER.** Licensee may not transfer the Software or any rights granted hereunder, except as provided herein, and any attempt to do so will be void and of no effect. Licensee may transfer its Software license to another party if (a) Licensee and the transferee execute Calyx's license transfer agreement; (b) Calyx consents to such license transfer; (c) the transferee agrees to be bound by the applicable license agreement; (d) Licensee removes the Software from its computer system(s) and destroys any back-up copies of the Software; and (e) a transfer fee totaling \$50.00 is paid to Calyx. Unique fees are charged for the transferring of Client Software only – see Point License Agreement or inquire with Calyx regarding license transfer fees. Calyx reserves the right to revise its license transfer policies at any time, without notice.
6. **ASSIGNMENT.** Licensee may not assign this Agreement, in whole or in part, without Calyx's prior written consent (which consent shall not be unreasonably withheld). In order to effect an assignment, Licensee shall work cooperatively with Calyx to complete all required paperwork. Subject to the foregoing, this Agreement shall be binding on and enforceable by the parties and Licensee's permitted assignee.
7. **USE OF ACCESS CODES.** Licensee shall be responsible for maintaining the confidentiality of any account IDs, passwords or logins ("Access Codes") provided to Licensee or established by Licensee for the use of Licensee's Software. Furthermore, Licensee is entirely responsible for any and all activities that occur under Licensee's Access Codes. Calyx will not be liable for any loss that Licensee may incur as a result of someone else using its Access Codes, either with or without knowledge.
8. **POINTCENTRAL SERVER URL RESOLVER/SSL CERTIFICATE.** If Licensee chooses to use Calyx's service for server URL resolver and SSL certificate, Licensee acknowledges and agrees that Calyx reserves the right to make changes to or discontinue such service.
9. **INTERFACES.** The Client Software includes links ("Interfaces") to numerous lenders, mortgage service providers, and other third parties ("Service Providers"). In the event Licensee intends to use or request the services and products of Service Providers, Licensee is solely responsible for reviewing and understanding the terms and conditions governing the usage of such Service Providers and their services and products. Licensee understands that Licensee is subject to the specific terms, fees, conditions, policies, and agreements imposed by such Service Providers. Calyx makes no representation or warranty of any kind concerning Licensee's use of such Service Providers and their services and products or the performance or results obtained by Licensee or its customers by using such Service Providers and their services and products.
10. **DISCLOSURE OF INFORMATION.** Interfaces enable Licensee to send information, including, but not limited to, a consumer's personal information, directly to Service Providers. Calyx is not responsible for any information sent by Licensee to such Service Providers and is not responsible for information requested by such Service Providers. Calyx assumes no responsibility as to whether information requested by a Service Provider is appropriate. It is Licensee's sole responsibility to contact a Service Provider regarding what particular type of information is being shared or exchanged, the Service Provider's use and sharing practices of such information, and whether the Service Provider has updated or revised its policies regarding the Service Provider's use and sharing practices. Calyx assumes no responsibility for the disclosure, dissemination, collection, use, sale, or sharing of information about a consumer and/or Licensee. It is Licensee's sole responsibility to ensure that Licensee and its employees and agents comply with any applicable laws, including but not limited to, all privacy laws, now and hereafter in effect, and to ensure that any information Licensee (including its employees and agents) shares with Service Providers is in compliance with applicable law, Licensee's own privacy notices and policies, and any consent or disclosure instructions provided by a consumer to Licensee.

11. **AUTOMATIC INTERFACE UPDATES.** Calyx has the right to add, remove, or modify the Interfaces listed in the Client Software. For the purpose of this Agreement, changes to the listed Interfaces are considered part of the Client Software and are subject to the terms of this Agreement. The automatic interface updates in no way extend the limited warranty period provided in Section 19.
12. **AVAILABILITY OF INTERFACES.** Licensee understands that Licensee's access to Service Providers through the Interfaces may be limited or interrupted from time to time, due to updates, maintenance, and repairs of such Interfaces by Calyx and/or Service Providers, and due to losses or interruption of access to the Interfaces due to causes beyond the control of Calyx, including, but not limited to, failure of telecommunication or digital transmission links, Internet slow-downs or failures, and unforeseen hardware or communication problems. Calyx shall not be liable to Licensee in connection with Licensee's inability to access Interfaces.
13. **RIGHT TO MONITOR.** Calyx has the right to monitor remotely all installations of the Software and the use of Interfaces (as defined above) included in the Client Software. During this process, Calyx will not collect or store any loan data. The Software will periodically transmit this installation and usage data to Calyx via the Internet. Licensee agrees not to disable or otherwise interfere with such network transmissions.
14. **SOFTWARE DEPLOYMENT.** Calyx reserves the right to determine the method by which the Software is deployed to Licensee.
15. **SOFTWARE RETIREMENT.** Calyx reserves the right to discontinue production and distribution of any versions of the Software. Calyx further reserves the right to determine which Software versions Calyx considers to be retired. Licensee may continue to use retired Software; however, technical support and upgrades will not be available. Retired Software is not available for electronic delivery and Calyx reserves the right to cease delivering retired Software via CD. Calyx's retired Software remains the intellectual property of Calyx.
16. **SOFTWARE REFUND.** To be eligible for a refund, Licensee must request refund within thirty (30) days of the Software invoice date. Software delivered to Licensee by CD must be returned to Calyx in its original packaging – seal unbroken. Calyx shall have the right to uninstall refunded Software which has been electronically deployed to Licensee. Refund processing will not occur until: (a) Calyx has received the unopened Software from Licensee; or (b) Calyx has uninstalled Licensee's Software. A processing fee will be applied to all refunds – calculated at 10% of the invoice total, to a maximum charge of \$50.00. Calyx reserves the right to revise its refund policies at any time, without notice.
17. **INTER-COMPANY COST RECOVERY.** In the event Licensee implements an inter-company cost recovery solution in connection with Client Software licensed, Licensee is required to: (a) remain in compliance with Section 1 (Grant of License) of this Agreement – the number of Client Software seats distributed to Licensee's employees cannot exceed the number of Seats licensed to Licensee; (b) inform its employees that there is no Client Software ownership transfer in connection with its cost recovery program; (c) offer its licensed Client Software seats to its employees at a price not to exceed the cost Calyx charges for the Client Software; and (d) use the words "Calyx Software Cost Recovery" whenever providing explanation of its cost recovery program so as to avoid confusing Licensee's collection of monies for the Client Software with a reselling of the Client Software.  
Licensee remains the licensee of all Client Software Seats used by its employees, and thus, remains obligated to all of the terms of licensing set forth in this Agreement. Notwithstanding the foregoing, as stated in Section 2 of this Agreement (License Restrictions), Licensee is restricted from reselling the Client Software/Server Software or giving the impression of being a reseller. **The inter-company cost recovery solution permitted as set forth in this Section is intended to allow Licensee to recoup some of its Client Software costs – it is not intended as a profit-making venture for Licensee.**
18. **TERM AND TERMINATION.** This Agreement will remain in force until terminated. Licensee may terminate this Agreement at any time by removing the Software from its computer system(s), as well as destroying all copies of the Software in its possession or control. Calyx may terminate this Agreement if Licensee fails to comply with the terms of this Agreement. In such event, Licensee must remove all Software from its computer system(s), and destroy all copies of the Software in its possession or control.
19. **LIMITED WARRANTY.** Calyx warrants that for thirty (30) days following the date of purchase, the media on which the Software is provided will be free from defects in materials and workmanship

under normal use. As Licensee's sole and exclusive remedy and Calyx's entire liability for any breach of this limited warranty, Calyx will promptly replace the defective media, at no charge, upon Calyx's receipt of the defective media from Licensee. THE LIMITED WARRANTY SET FORTH IN THIS SECTION IS IN LIEU OF AND CALYX EXPRESSLY DISCLAIMS ALL OTHER WARRANTIES AND CONDITIONS, EXPRESS OR IMPLIED, INCLUDING ANY IMPLIED WARRANTIES AND CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NONINFRINGEMENT, AND ANY WARRANTIES AND CONDITIONS ARISING OUT OF COURSE OF DEALING OR USAGE OF TRADE, AND ANY WARRANTIES THAT THE SOFTWARE IS ERROR-FREE, WILL OPERATE WITHOUT INTERRUPTION, AND IS COMPATIBLE WITH ALL EQUIPMENT AND SOFTWARE CONFIGURATIONS. NO ADVICE OR INFORMATION, WHETHER ORAL OR WRITTEN, OBTAINED FROM CALYX OR ELSEWHERE WILL CREATE ANY WARRANTY OR CONDITION NOT EXPRESSLY STATED IN THIS AGREEMENT.

20. **LIMITATION OF LIABILITY.** CALYX'S TOTAL LIABILITY TO LICENSEE FROM ALL CAUSES OF ACTION AND UNDER ALL THEORIES OF LIABILITY WILL BE LIMITED TO AND WILL NOT EXCEED THE AMOUNTS PAID TO CALYX BY LICENSEE FOR THE SOFTWARE. IN NO EVENT WILL CALYX BE LIABLE TO LICENSEE FOR ANY SPECIAL, INCIDENTAL, EXEMPLARY, PUNITIVE, OR CONSEQUENTIAL DAMAGES (INCLUDING LOSS OF USE, DATA, BUSINESS, OR PROFITS) OR FOR THE COST OF PROCURING SUBSTITUTE PRODUCTS ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT OR THE USE OR PERFORMANCE OF THE SOFTWARE, WHETHER SUCH LIABILITY ARISES FROM ANY CLAIM BASED UPON CONTRACT, WARRANTY, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY, OR OTHERWISE, AND WHETHER OR NOT CALYX HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH LOSS OR DAMAGE. THE FOREGOING LIMITATIONS WILL SURVIVE AND APPLY EVEN IF ANY LIMITED REMEDY SPECIFIED IN THIS AGREEMENT IS FOUND TO HAVE FAILED OF ITS ESSENTIAL PURPOSE.
21. **INDEMNIFICATION.** Licensee agrees that Licensee shall, at its expense, defend, indemnify, and hold harmless, Calyx and its affiliates (including, its officers, directors, employees, agents, and attorneys) from and against any and all claims, demands, liabilities, costs, expenses, (including attorney fees), losses, damages, judgments, or settlements arising or resulting from any claims, demands, actions, and other proceedings by any party, including any third party, arising out of, or relating to: (a) this Agreement; (b) Licensee's use of the Software (including use of the Interfaces), and any other Calyx products or services; (c) Licensee's use of Service Providers and their products and services; (d) any act or omission of Service Providers, and agents and employees of such Service Providers; (e) the collection, distribution, dissemination, sharing, use, or sale of information provided to Service Providers; (f) Licensee's violation of any local, state, federal, or international laws, or breach of this Agreement; and (g) any act or omission by Licensee, its agents and employees, for any services agreed to be performed by any third party.
22. **GOVERNING LAW/VENUE.** This Agreement will be governed by and construed in accordance with the laws of the State of California, without regard to or application of conflicts of law rules or principles. The appropriate venue for any legal action shall be exclusively the state and federal courts of California.
23. **ATTORNEYS' FEES.** In the event of any litigation of any controversy or dispute arising out of or in connection with this Agreement, its interpretation, its performance, or the like, the prevailing party will be entitled to reasonable attorneys' fees and expenses, court costs, and reasonable costs for expert and other witnesses attributable to the prosecution or defense of that controversy or dispute.
24. **EXPORT LAW.** Licensee agrees to comply fully with all U.S. export laws and regulations to ensure that the Software, any technical data related thereto, or any direct product thereof are not exported or re-exported directly or indirectly in violation of, or used for any purposes prohibited by, such laws and regulations.
25. **GOVERNMENT USERS.** The Software is "computer software" and "commercial computer software documentation," as such terms are used in FAR 12.212. Any use, duplication, or disclosure of the Software by or on behalf of the U.S. Government is subject to restrictions as set forth in this Agreement. Manufacturer is Calyx Software, with offices at 6475 Camden Avenue, Suite 207, San Jose, CA 95120.
26. **LICENSEE CONTACT INFORMATION CHANGE.** So that Calyx may effectively provide Licensee with Software updates, Licensee must notify Calyx of any contact information change. In order to

implement a requested change, the appropriate Calyx form is required to be completed by Licensee's primary contact and processed by Calyx.

27. NOTICES. All notices or approvals required or permitted under this Agreement are required to be in writing and delivered by confirmed facsimile transmission, by overnight delivery service, or by certified mail, and in each instance will be deemed given upon receipt. All notices or approvals will be sent to the addresses set forth in the applicable ordering document or invoice or to such other address as may be specified by either party to the other in accordance with this Section.
28. NON-EXCLUSIVE REMEDY. Except as expressly set forth in this Agreement, the exercise by either party of any of its remedies under this Agreement will be without prejudice to its other remedies under this Agreement or otherwise.
29. WAIVER. The failure by either party to enforce any provision of this Agreement will not constitute a waiver of future enforcement of that or any other provision. Any waiver, modification, or amendment of any provision of this Agreement will be effective only if in writing and signed by authorized representatives of both parties.
30. SEVERABILITY. If any provision of this Agreement is held to be unenforceable or invalid, that provision will be enforced to the maximum extent possible and the other provisions will remain in full force and effect.
31. HEADINGS. The Section headings contained in this Agreement are inserted for convenience only and should not affect in any way the meaning or interpretation of this Agreement.
32. ENTIRE AGREEMENT. This Agreement is the complete and exclusive understanding and agreement between the parties regarding its subject matter, and supersedes all proposals, understandings, or communications between the parties, oral or written, regarding its subject matter.
33. SURVIVAL. The terms of Sections 2, 4, 10, 19-24, 28-30, and any other provisions which by their nature should survive, shall survive the termination of this Agreement.
34. ACCEPTANCE. Licensee agrees that Licensee has read this Agreement and hereby accepts its terms.
